THE NATIONAL POLICE PROMOTION FRAMEWORK

The National Police Promotion Framework (NPPF) is a new process for police officers seeking promotion to the rank of Sergeant or Inspector.

As an officer you will benefit from developing through a supported work programme that gives you the necessary skills for your rank as well as an opportunity to obtain a national qualification which is recognised outside the Police service.

THE PROMOTION PROCESS

The National Police Promotion Framework requires officers to undertake a four-step process for promotion to Sergeant or Inspector.

- The first step is to be considered competent in your current rank
- The second step is to sit the OSPRE Part 1 exam in Criminal Law and Policing Procedures
- The third step is to be assessed against rank-specific competencies in a force selection process
- And the final step is to undergo a 12-month temporary promotion where you will be assessed in the workplace.

It is mandatory to complete all four steps, the final step leading to a professional qualification in police management.
