» QUALIFICATIONS SUMMARY

The Reserve Soldier Conversion to Officer Course (SCOC) has been accredited by CMI with **CMI Level 7 Qualifications in Strategic Management and Leadership** with the completion of additional work to achieve an Award with a Total Qualification time (TQT) of 90 hours or a Certificate with a TQT of 250 hours.

These qualifications are designed for managers who have the authority and personal inspiration to translate organisational strategy into effective operational performance. The qualifications require managers to build on their strategic management and leadership skills and to focus on the requirements of implementing the organisation's strategy.

CMI qualifications at RQF Level 7 portray practical skills and competences that are rated in academic terms as being comparable to Master's Degrees, Integrated Master's Degrees, Postgraduate Diplomas, Postgraduate Certificate in Education (PGCE) and Postgraduate Certificates.
