#### » QUALIFICATIONS SUMMARY

The Advanced Management and Leadership Course (AMLC) has been accredited by CMI at CMI Level 4 Diploma in Management and Leadership with Total Qualification Time of 600 hours.

Level 4 qualifications are designed for junior managers to develop personal management capabilities, and grow professional management skills including decision-making, managing team dynamics and delegation.

The course has also been accredited to the CMI Level 5 Certificate in Management and Leadership, which you can top up with additional work and which may therefore make SLCs eligible.

In addition, the course has also been accredited with the CMI Level 5 Award in Coaching and Mentoring.

CMI qualifications at RQF Level 5 portray practical skills and competences that are rated in academic terms as being comparable to Foundation Degrees and Higher National Diplomas (HND). These qualifications are for the development of the role and skills of managers. These qualifications aim to develop personal management capabilities, make effective use of information in decision-making, operations and the development of the skills in managing people.
