Chris Tanner, Founder, Harvst



After graduating with a degree in Electronic Engineering, Chris moved full time into running the skateboard business he had started earlier in his university course. This grew to become a global brand. In order for the growing business to stay efficient, Chris developed an in-house software system to combine manufacturing, retail, wholesale and production data along with accounting information, all in the same platform. This then became the spin-out SaaS company Brightpearl which, after a few Venture Capital investment rounds, went on to sell to Sage PLC in 2022. Having moved away from core operations at Brightpearl, and looking for something else to throw energies into, Chris launched Harvst in 2020, a green-tech business

manufacturing climate-controlled greenhouses, hydroponics systems, and smart irrigation systems for the home gardener. This currently operates from Cardigan, in West Wales, where Chris lives with his family. In 2015, Chris launched Lend Engine, a SaaS platform for Libraries of Things to manage their operations. Lend Engine is now a global leader in the not-for-profit sector of community libraries, with the goal of helping people to borrow rather than buy items they only need on an occasional basis. Al is used regularly in the development and testing processes. In 2024 Chris launched Pobl-dda, a co-working office space in Cardigan. This runs autonomously with the help of a booking platform generated entirely with the help of Al.

Dr Cecilia Tsui is a serial entrepreneur, an executive coach and an educator. She enjoys working at the intersection of society, government, education and business. Her work adopts a multidisciplinary approach, and embraces key arenas, including: (a) Innovation, (b) Entrepreneurship, (c) Sustainability & Built Environment, (d) Technological Change (Development of Al — Ethics, Regulations, Organisational Transformation) as well as (e) Management and Leadership. Cecilia's business links leading UK academic / business institutions to Hong Kong - China - Asia Pacific to advance knowledge and practice, i.e. key units of the University of Hong Kong and University of Cambridge.

In pursuing her PhD on "Quality Assurance in Higher Education – A Hong Kong Perspective" (supervised by Professor Lewis Elton (UCL) and Professor Cheng Kai-ming (HKU), Dr Tsui has visited major higher education research centres in Europe, including UNESCO IIEP (International Institute for Educational Planning), OECD IMHE (Institutional Management in Higher Education). As well, she has interviewed key stakeholders in different countries. Cecilia's work always embrace an international dimension.

Dr Cecilia Tsui has made contributions to different organisations. She is a Companion (CCMI) of the Chartered Management Institute UK, and the Founder Chair of its Hong Kong Branch (1999-2003), when Sir Sze-yuen Chung (鍾士元爵士) was the Hon President. Also, Cecilia serves as a mentor and a judge for universities, including the Cambridge Institute for Sustainability leadership (University of Cambridge UK), and the Hong Kong Social Enterprise Challenge of the Chinese University of Hong Kong.

Dr Tsui is an Advisor (Management Education & Research), MLA Academy (formerly Peter F Drucker Academy). Upon invitation, during 2019-2020, Cecilia partnered with Professor Joseph Maciariello (ally and closest collaborator of Peter F Drucker) to develop an MBA course on "Innovation, Entrepreneurship, and Technological Change" (advocating human-centric approach in applying Artificial Intelligence for organisational development to achieve socio-economic impacts).

Dr Cecilia Tsui is the Founder Executive Director, Innovation Forum Hong Kong (a non-profit initiative), responsible for development in Asia Pacific for the Global Innovation Forum, headquartered in Cambridge UK (video: IFHK (vimeo.com). This global network fosters young PhDs and Postdocs to pursue scientific innovation and entrepreneurship (in life sciences /sustainability).

Having started her career at Swire Duro Limited, Dr Cecilia Tsui possesses experiences in business and education. In the early 1980s, at Citicorp International Limited (and its subsidiary Asia Pacific Capital Corporation), Cecilia facilitated the merger of Merrill Lynch



with Sun Hung Kai Finance, the establishment of Sun Hung Kai Bank, and a number of international syndicated loans.

In the field of higher education, Dr Tsui has served as a consultant for a Business Ethics course of HKU SPACE and served the Preparatory Committee of the CUHK-TWGHs Community College (presently Tung Wah College). Furthermore, at the Open University of Hong Kong, Dr Tsui has developed courses in Business, Management, and General Education. She has conducted research studies comparing "Administrative Styles of Open Universities in Asia", as well as assessing "Trainers' Competencies"; jointly organised with the Management Development Centre, Vocational Training Council Hong Kong.
